Statement of Deficiencies

1715-A.5: State Central Registry

1715-A.5: Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a current, completed state central registry disclosure form indicating no justified (valid) finding of abuse or neglect by the DCFS, or a current determination from the DCFS indicating that the individual does not pose a risk to children.

Finding:

Based on record review:Provider failed to have documentation of a completed state central registry disclosure form (SCR 1) on site and available for review at the center prior to a previously completed form expiring (1705.B). 2 of 20 staff, S14 and S18 failed to have documentation of the completed form prior to expiration and were not on premises during licensing visit to complete a form.

1717-A: Independent Contractors Records

1717-A: Independent Contractors. The following information shall be maintained for all independent contractors, including but not limited to therapeutic professionals, extracurricular personnel, contracted transportation drivers, Department of Education, Office of Early Childhood staff and local school district staff:

- 1. an information form that includes the person's name, address and phone number
- 2. a list of duties performed while present at the center; and

3. documentation of a fingerprint based satisfactory criminal background check dated prior to the individual being present at the center or documentation of the paid, adult staff member not otherwise counted in child to staff ratios that accompanied the contractor at all times while the contractor was on the center premises, to include the date, contractor arrival and departure time, language stating that the contractor was accompanied by the staff member at all times while on the premises, and the signature of both the contractor and the accompanying staff member.

Finding:

Based on record review and interview: Provider did not have documentation of a fingerprint based satisfactory criminal background check dated prior to the individual being present at the center for independent contractor O1.

1719-A.-B.: Orientation Training

1719-A.-B.: Within seven calendar days of date of hire, and prior to assuming sole responsibility for any children, each staff member shall receive orientation to the policies and practices of the center that at a minimum shall include:

- 1. child abuse identification and reporting;
- 2. emergency preparation;
- 3. licensing regulations; and
- 4. safe sleep practices,

Within 30 calendar days of date of hire, each staff member shall receive orientation to the additional policies and practices of the center that at a minimum shall include:

- 1. child development;
- 2. child guidance;
- 3. learning activities;
- 4. health and safety;
- 5. shaken baby prevention;

Finding:

Based on record review and interview: Staff S8 and S20 hired after July 1, 2015 failed to have the following orientation training within 7 days of date of hire:

4. safe sleep practices

Based on record review and interview Staff S8 hired after July 1, 2015 failed to have the following orientation training within 30 days of date of hire: 5. shaken baby prevention

1725-A.-D.: Medication Management Training

1725-A.-D.: A. All staff members who administer medication shall have medication administration training.

B. Whether administering medication or not, each early learning center shall have at least two staff members trained in medication administration.

- C. Such training shall be completed every two years with an approved Child Care Health Consultant.
- D. A licensed practical nurse (LPN) or registered nurse (RN) with a valid nursing license shall be considered to have medication administration training.

Based on record review: The staff person, S11 administering medication did not have documentation of training in medication administration.

1915-A: Health Services - Observation

1915-A: Observation. Upon arrival at the center, the physical condition of each child shall be observed for possible signs of illness, infections, bruises or injuries, and when something is observed, it shall be documented and such documentation shall include an explanation from the parent or child.

Finding:

Based on record review: The provider did document observations, when something is observed, noted on children upon arrival to the center. However, an explanation from parent and/or child were not documented.

1915-B.&C: Health Services - Parental Notification

1915-B.&C:

B. Reporting. Incidents, injuries, accidents, illnesses, and unusual behavior shall be documented and reported to the parent no later than when the child is released to the parent or authorized representative on the day of the occurrence.

Immediate Notification. The parent shall be immediately notified in the following circumstances: C.

- blood not contained in an adhesive strip; 1.
- 2. head or neck or eye injury;
- 3. human bite that breaks the skin;
- animal bite: 4
- 5. impaled object;
- broken or dislodged teeth; 6.
- allergic reaction skin changes (e.g. rash, spots, swelling, etc.); 7.
- unusual breathing; 8.
- symptoms of dehydration; 9.

- 1. On 11/6/15 at 9:40am, C1 scratched himself on the cheek causing bleeding- No Parental Notification Time was documented
- 2. On 12/9/15 at 10:30am, C2 hit face and busted chin and nose- No Parental Notification Time was documented
- 3. On 11/18/15 at 8:30am, C2 hit face on shelf resulting in a bump on the forehead- No Parental Notification Time was documented
- 4. On 11/11/15 at 10:00am, C2 tripped and hit side of head resulting in a bump on the forehead- No Parental Notification Time was documented 5. On 8/19/15 at 1:30pm, C3 bumped side of forehead - No Parental Notification Time was documented
