# Statement of Deficiencies

## 713.A.: Office of Public Health, State Fire, City Fire Approval

713.A.: Annual licensing inspections by the department, current approvals by the Office of Public Health, Office of State Fire Marshal, and city fire (if applicable), and academic approval by the department (if type III center) shall be required before the expiration of an existing license. However, if a center has documentation establishing that the center requested an inspection by the Office of Public Health or the Office of State Fire Marshal prior to the expiration of the existing license, these approvals may be submitted to the department within 90 calendar days of the date of the license renewal.

#### Finding:

713.A. Based on record review: The Provider lacked documentation of a current annual inspection and approval from Office of Public Health. The date of the last approval is 11/9/17. S1 stated the Health Inspector has inspected the center and will be emailing the current inspection documentation and it will be submitted once received.

### 1723.A.&B.: CPR Certification

1723.A.&B.: A. Infant and child CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR through training approved by the department.

B. Adult CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in adult CPR through training approved by the department.

#### Finding:

1723.A. Based on record review: The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in infant and child CPR through training approved by the department. The Specialist reviewed staff files and verified that 0 of 0 staff had documentation of this certification. S1 stated that a CPR training course has been scheduled and documentation will be submitted once received.

### 1723.C.: Pediatric First Aid

1723.C.: Pediatric First Aid. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in pediatric first aid through training approved by the department.

#### Finding:

1723.C. Based on record review: The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in Pediatric First Aid through training approved by the department. The Specialist reviewed staff files and verified that 0 of 0 staff had documentation of this certification. S1 stated that a PFA training course has been scheduled and documentation will be submitted once received.

#### 1901.G.&H.: Equipment

1901.G.&H.: G. All equipment used by children shall be maintained in a clean and safe condition and in good repair. H. Moveable equipment shall be secured and supported so that it shall not fall or tip over.

#### Finding:

1901.G.: Based on observation: All of the center equipment used by children was not maintained in a clean and safe condition and in good repair. The Specialist observed the playground area and saw toys that were not in good repair. The Specialist observed a toy with a broken piece in the center and another toy with a missing wheel. The Specialist also observed that the playground was not in a clean and safe condition due to observing 2 empty bottles for cleaning products on the playground as well. The empty bottles were removed from the playground area during the visit.

#### 1901.Q.: The Safety Box

1901.Q.: The center shall post a copy of the current The Safety Box newsletter issued by the Louisiana Office of the Attorney General and shall immediately remove from the early learning premises any items listed as recalled.

#### Finding:

1901.Q. Based on observations: The Provider did not post 'The Safety Box' newsletter issued by the Louisiana Office of the Attorney General.

## 1903.C.: Free of Hazards

1903.C.: Indoor and outdoor areas shall be free of hazards.
