5306-F: Discipline

5306.F. The provider shall establish a policy in regard to methods of discipline. Any form of punishment that violates the spirit of this standard of discipline, even though it may not be specifically mentioned as forbidden, is prohibited. This written posted policy shall clearly state ALL types of positive discipline that are used and that the following methods of discipline are prohibited:

- No child shall be subject to physical punishment, corporal punishment, verbal abuse or threats.
- Cruel, severe, unusual, or unnecessary punishment shall not be inflicted upon children.
- Derogatory remarks shall not be made in the presence of children about family members of children in care or about the children themselves
- No child or group of children shall be allowed to discipline another child.
- When a child is removed from the group for disciplinary reasons, he shall never be out of sight of a staff member.
- No child shall be deprived of meals or snacks or any part thereof for disciplinary reasons.

Finding:

7306.F. (OLD TAG# 5306.F.) Provider used a prohibited method of discipline as a child was subject to verbal abuse or threats. FINDINGS INCLUDE:

On 1/10/2011, S1 was observed screaming at a child (C1) during naptime according to statements obtained by specialist. S1 was terminated by the provider on the next day.

5312-D.1: Continuing Education

5312.D.1. The director shall provide opportunities for continuing education of staff through attendance at child care workshops or conferences, for paid and non-paid staff who are left alone with children, or who have supervisory or disciplinary authority over children. The child care staff, excluding foster grandparents, shall obtain 12 clock hours of approved training per center's anniversary year in job related subject areas. At least three of the 12 clock hours of training for directors/director designees shall be in administrative issues. Documentation shall consist of attendance records or certificates received by staff. This is in addition to the required training hours from the Department of Health and Hospitals, pediatric first aid and infant/child/adult CPR. Medication administration training by a Child Care Health Consultant may count toward fulfilling three of the mandated 12 hours of continuing education training. All training shall have prior approval by the Department of Social Services. Original certificates shall be made available upon request.

Finding:

7312.D.1 (OLD TAG# 5312.D.1.) There was no documentation that paid and non-paid staff, S1, who are left alone with children, or who have supervisory or disciplinary authority over children have obtained 12 clock hours of approved training per center's anniversary year. This is in addition to the required training from the Department of Health, Pediatric First Aid and Infant/Child/Adult CPR. FINDINGS INCLUDE:

Upon specialist observation of personnel files, S2 only received 6 training hours for the last licensure year.

5312-E.1: CPR

5312.E.1. A minimum of at least 50 percent of all staff on the premises and accessible to the children at all times shall have documentation of current infant/child/adult certification in CPR. Original cards shall be made available upon request. This training shall be approved by the Department of Social Services prior to acceptance.

Finding:

7312.E.1. (OLD TAG# 5312.E.1.) The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children have current approved Infant/Child/Adult certification in CPR.

FINDINGS INCLUDE:

On date of visit, specialist observed 1 of 8 staff present to have documentation of current infant/child/adult certification in CPR. Provider stated that the center has training scheduled on February 26, 2011.

5312-E.3: PFA

5312.E.3. A minimum of at least 50 percent of all staff on the premises and accessible to children shall have documentation of current pediatric first aid certification. Original cards shall be made available upon request. This certification shall be approved by the Department of Social Services prior to

7312.E.3. (OLD TAG# 5312.E3.) The Provider did not have documentation that at least 50 percent of the staff on the premises and accessible to children at all times has current approved Pediatric First Aid training.

FINDINGS INCLUDE:

On date of visit, specialist observed 1 of 8 staff present to have documentation of Pediatric First Aid training. Provider stated that the center has training scheduled on February 26, 2011.

5327-A: Locked Harmful Substances and Equipment

5327.A. Prescription and over-the-counter medications, poisons, cleaning supplies, harmful chemicals, equipment, tools and any substance with a warning label stating it is harmful or that it should be kept out of the reach of children, shall be locked away from and inaccessible to children. Whether a cabinet or an entire room, the storage area shall be locked.

Finding:

7327.A. (OLD TAG# 5327.A.) Prescription and over-the counter medications, poisons, cleaning supplies, harmful chemicals, equipment, tools, and any substance with a warning label stating it is harmful to or that it should be kept out of the reach of children were not locked away from children. FINDINGS INCLUDE:

Specialist observed a water/bleach solution in the bathtub of the unlocked bathroom between classroom #3 and #4 which is within the reach of children. The bathtub's drain was stopped up, not allowing the water/bleach solution to drain. Provider corrected this during licensing visit.
