1507-A: A daily attendance record for children shall be maintained that shall:

- 1. include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released;
- 2. accurately reflect children on the center premises at any given time; and
- 3. be used to sign in and out if a child leaves and returns to the center during the day.

Finding:

1507-A Based on record review Children's daily attendance record failed to accurately reflect the number of children on the premises as evidenced by 35 children were in attendance however 38 were signed in. S1 discovered one parent had signed her children as being attendance however they were not

1723-A.&B.: CPR Certification Not Met

1723-A.&B.: A - Infant and child CPR - Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR.

B - Adult CPR - Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in adult CPR.

Finding:

1723-A.&B.: A - Infant and child CPR; Based on record review there failed to be at least Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, with current certification in infant and child CPR. After S9 leaves premises during her flex hours and S7 leave premises there failed to be at least 4 staff present with current certification as required and only 2 of the 9 staff present had current certification available.

1723-C.-D.: Pediatric First Aid Not Met

1723-C.-D.:

- C. Pediatric First Aid Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in Pediatric First Aid.
- D. Certification A copy of the certification for each such staff member shall be on-site at all times and available for inspection by the Licensing Division.

Finding:

Based on record review there failed to be at least Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, with current Pediatric First Aid. After S9 leaves premises during her flex hours and S7 leave premises there failed to be at least 4 staff present with current certification as required and only 2 of the 9 staff present had current certification available.

1901-M: Strings and Cords Not Met

1901-M: Strings and cords, including but not limited to those found on equipment, window coverings, televisions and radios, shall be inaccessible to children under age 4.

1901-M Based on observations hanging cords were observed hanging from mounted television in the large preschool classroom.
