- 1. include the first and last name of the staff member or owner and arrival and departure times;
- 2. accurately reflect the staff members and owners on the center premises at any given time; and
- 3. be used to document staff members and owners who leave and return to the center during the day

Finding:

1507.B. Based on record review: S3's staff and owner's daily attendance record did not accurately reflect persons on the child care premises at any given time. S3's staff and owner attendance record does not include the first and last name of the staff member or owner and the arrival and departure times

- On 2/13/2019, there is no departure time for S2.
- On 2/21/2019, there is no arrival and departure times for S2.

S2 stated that on 2/21/2019, he arrived at the center at 7:01am and left for lunch at 12:35pm. The Specialist observed S2 arrive at the center at 2:03pm.

1711.A.&B.&D.&G.: Child to Staff Ratio

Not Met

1711.A.&B.&D.&G.: A. Child to staff ratios are established to ensure the safety of all children.

- B. Minimum child to staff ratios shall be met at all times.
- 1. There shall be a minimum of two staff members present at an early learning center when more than one child is present.
- 2. Only those staff members directly providing care, supervision or guidance to children shall be counted in the child to staff ratios.

Finding:

1711.B1. Based on record review/observations: S3 did not have at a minimum of two child care staff present at an early learning center when more than one child is present. On 2/21/2019, the Specialist observed one staff, S1, supervising two children, ages 5mos and 1yr old, between 1:45pm - 2:03pm. S1 stated that S2 was on lunch and should return in ten minutes. Ratio was met at 2:03pm when S2 arrived at the center.

1723.A.&B.: CPR Certification

1723.A.&B.: A. Infant and child CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR through training approved by the department.

B. Adult CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in adult CPR through training approved by the department.

Finding:

1723.A. Based on record review: S3 did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in infant and child CPR through training approved by the department. On 2/21/2019, 2 of 2 staff did not have documentation of this certification.

1723.C.: Pediatric First Aid Not Met

1723.C.: Pediatric First Aid. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in pediatric first aid through training approved by the department.
