

Statement of Deficiencies

1901-J.&K.: Items That Can be Harmful to Children

Not Met

1901-J.&K.: Items that can be harmful to children, such as medications, poisons, cleaning supplies and chemicals, and equipment, tools, knives and other potentially dangerous utensils, shall kept in a locked cabinet or other secure place that ensures they are inaccessible to children. Plastic bags, when not in use, regardless of purpose or use, shall be made inaccessible to children.

Finding:

1901-J.&K: Based on observations on 3/6/18, the Specialist observed items that can be harmful to children in the following areas of the center.

Classroom #5

Specialist observed a package of Well Beginnings baby wipe that had a warning labels that read to keep them out of reach of children on the top of the toilet. Specialist observed a unlocked plastic 3 drawer storage that had empty shopping bags in the top drawer. Items were removed.

Classroom#7

Specialist observed an unlocked plastic 3 drawer storage container that contained 1 bottle of baby powder, 1 tube of Aquaphor, 1 tube of Zinc oxide, 1 tube of creamy diaper rash cream, and 1 tube of boudreaux butt paste. Items were removed from the drawer.

Classroom#8

Specialist observed small unlocked plastic container with 3 drawers sitting on the teacher's desk that contained 3 black and silver staple pullers, and 1 pair of adult scissors with a beige handle. Items were removed.

Classroom#12

Specialist observed 1 can of Valspar Reserved paint sitting on a small red table and 1 box of great value sandwich bags that were sitting on a black plastic shelf. Items were removed.

Classroom#14

Specialist observed a small green container with 1 bottle of equate baby powder, 1 tube of A&D ointment, 1 tube of CVS diaper rash cream, 2 tubes of parent choice diaper rash cream, and 1 tube of equate diaper rash cream. Specialist observed empty plastic shopping bags in the drawer. Items were removed.

Building#2

Classroom#2

Specialist observed 1 pair of adult scissors with a blue handle in a unlocked 3 drawer plastic container. Specialist observed empty plastic shopping bags. Items were removed.

Classroom#4

Specialist observed 1 can of Equate shave foam, 1 gallon of Great Value easy pour bleach, 2 containers of Great Value Lemon Scent wipes, 1 can of glad air freshener, 2 cans of Pro Series Disinfectant Spray under the cabinet which had a broken white latch, and 1 box of baking soda. Items were removed.

Classroom#5

Specialist observed 1 bottle of Comet Bathroom Cleaner, 2 cans of Glade air freshner, 1 can of Homax Wall texture, 3 can of Pro Series Disinfectant Spray, 3 container of Great Value Lemon Scent disinfecting wipes, 1 box of Great Value gallon storage bags, 1 box of Mule Team Borax, 1 bottle of Equate Multi-Purpose eye contact solution, and 1 box of Pure Baking soda under the cabinet which had a broken latch. All items were removed. Specialist observed 1 unlocked drawer that had 3 black and silver staple pullers. Items were removed.

1901-P: Staff Personal Belongings

Not Met

1901-P: The personal belongings of center staff members shall be inaccessible to children.

Finding:

1901-P Based on observations on 3/6/18, the Specialist observed a syro-foam beverage cup with an unknown liquid in S3's classroom sitting on the teacher's desk. Cup was in reaching distance of the children. The cup was not removed.

1903-C: Free of Hazards

Not Met

1903-C: Indoor and outdoor areas shall be free of hazards.

Finding:

1903-C Based on observations on 3/6/18, the center playground was not free of hazards. Specialist observed that the wooden fence on the large

playground near the tin building had 5 pieces of broken wood.

Classroom #8

Specialist observed a 1 year old wearing a teething necklace. The necklace poses a choking hazard. Child's necklace was removed.

1907-E.2: Cribs Free of Toys and Other Soft or Loose Bedding

Not Met

1907-E.2: Cribs shall be free of toys and other soft or loose bedding, including comforters, blankets, sheets, bumper pads, pillows, stuffed animals and wedges when the child is in the crib.

Finding:

1907-E.2 Based on observations on 3/6/18, the Specialist observed 1 infant who was awake in a crib that was playing with a loose blanket in classroom#3. Blanket was removed.

1919-D.3.&4.: Food Service and Nutrition - Reasonable Time and Food Served

Not Met

1919-D.3.&4.:

3. Children shall be allowed a reasonable time to eat each meal and snack. Children shall not be forced to finish all their food.

4. Food shall be given to children on individual plates, napkins, paper towels or in cups, as appropriate.

Finding:

1919-D.4 Based on observation on 3/6/18, the Specialist noted that food for the 8 children in classroom #16 was not served on individual plates, napkins, paper towels or in cups. The children were eating food directly from the feeding table tray.
