Finding:

1501-A Based on observations: The facility failed to operate within their licensed capacity as evidenced by: -The center's posted license lists their capacity at 25 and 26 children were present on today. Based on a review of child attendance logs from 3/28/17-4/3/17, the center had up to 27 children at one time on 3/28/17, up to 34 children present at one time on 3/29/17, up to 28 children present at one time on 3/31/17 and up to 34 children present at one time on 4/3/17.

1715-A.5: State Central Registry

1715-A.5: Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a current, completed state central registry disclosure form indicating no justified (valid) finding of abuse or neglect by the DCFS, or a current determination from the DCFS indicating that the individual does not pose a risk to children.

1715-A.5 Based on record review: The facility failed to have documentation of a current, completed State Central Registry Disclosure form indicating no justified finding of abuse or neglect for 1 newly hired staff and failed to have the form updated annually for 4 additional staff.
