Statement of Deficiencies

1507.A.: Daily Attendance Records - Children

1507.A.: A daily attendance record for children shall be maintained that shall:

- 1. include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released;
- accurately reflect children on the center premises at any given time; and 2.
- be used to sign in and out if a child leaves and returns to the center during the day. 3.

Finding:

1507.A. Based on record review/observation: The center's daily attendance record for children did not accurately reflect the children on the child care premises at any given time as 34 children were present and 33 children were signed in on the log.

1911.G.: Pacifier Attached

1911.G.: Pacifiers attached to strings or ribbons shall not be placed around the neck or attached to the clothing of a child.

Finding:

1911.G. Based on observations: A pacifier that was attached to strings or ribbons was attached to the clothing/bib of a child. Specialist observed C1 with a pacifier attached to a string/ribbon which was attached to his clothing/bib. Corrected by S2 at the time of observation.

1915.B.&C.: Health Services - Parental Notification

1915.B.&C.:

B. Reporting. Incidents, injuries, accidents, illnesses, and unusual behavior shall be documented and reported to the parent no later than when the child is released to the parent or authorized representative on the day of the occurrence.

- C. Immediate Notification. The parent shall be immediately notified in the following circumstances:
- blood not contained in an adhesive strip; 1.
- head or neck or eye injury; 2.
- human bite that breaks the skin; 3.
- 4. animal bite;
- 5. impaled object:
- broken or dislodged teeth; 6.
- 7. allergic reaction skin changes (e.g. rash, spots, swelling, etc.);
- unusual breathing; 8.
- symptoms of dehydration; 9.
- temperature reading over 101° oral, 102° rectal, or 100° axillary; or 10.
- injury or illness requiring professional medical attention. 11.

Finding:

1915.B&C. Based on record review: S3 did not have documentation of immediate notification to the parent when the following occurred to a child: Fever of 102.8. Incident occurred at 3:35 p.m. on 3/26/19 and there is no documentation the parent was notified. S3 stated the parent picked up the child shortly after being notified on 3/26/19.

1921.A.: Emergency Preparedness and Evacuation Planning

1921.A.: Emergency and Evacuation Plan. The director shall consult with appropriate state and local authorities and shall establish and follow a written multi-hazard emergency and evacuation plan to protect children in the event of emergencies that at a minimum shall:

1. address any potential disaster related to the area in which the center is located;

2. include procedures for sheltering in place, lockdown and evacuation to a pre-determined site for potential threats to the safety, health and well-being of children in care;

3. include specific procedures for handling infants through two year olds, including food and formula;

4. include specific procedures for handling children with special needs, including the evacuation and transportation of children in wheelchairs;

5. include a system to account for all children;

6. include a system, and a back-up system, for contacting parents and authorized third party release caretakers;

7. include a system to reunite children and parents following an emergency;

8. include procedures for providing information about the emergency plan to parents at the time of enrollment and when changes occur;

9. be reviewed annually for accuracy and updated as changes occur; and

10. be reviewed with all staff at least once per year.

11. practice drills shall be conducted at least twice per year to include all children and shall be documented.

1921.E.: Tornado Drills

1921.E.: Tornado drills shall be conducted at least once per month in the months of March, April, May, and June at various times of the day necessary to include all children and shall be documented.

Finding:

1921.E. Based on record review: S3 did not have documentation of tornado drills that were conducted at least once per month during the months of March, April, May, and June. Date of last tornado drill was 6/14/18.
