No authorization was provided for C1 as child has been enrolled as of 6/9/10. Center has been informed C1 needs epipen since 6/9/10 meeting with S7 and center staff.

5323-B.3: Outdoor - Enclosed

Not Met

5323.B.3. The outdoor play space lacked an enclosure with a fence or other barrier in such a manner as to protect the children from traffic hazards, to prevent the children from leaving the premises without proper supervision, and to prevent contact with animals or unauthorized persons.

Finding:

7323.B.3 (old tag #5323.B.3.) The outdoor play space lacked an enclosure with a fence in such a manner as to protect the children from traffic hazards, to prevent the children from leaving the premises without proper supervision, and to prevent contact with animals or unauthorized persons. Specialist observed the fence enclosing the center from parking lot open upon arrival; when checking the outdoor play yard Specialist and S1 observed the fence enclosing the play yard open when the children where outdoors playing at the time; children could have left the outdoor play area.

Finding:

7327.L (old tag #5327.L.) The center yard was not free of hazards as specialist and S1 observed the following:

OUTSIDE: ACTIVE FIRE ANT PILES: on the play yard embedded in the boarder of the soft surface area of the play area- the boarder had fire ants through the boarder and coming out the side.

INSIDE: Broken Top Cabinet door in S1 classroom materials can fall out of the cabinet with out door on to child.
