CHILDREN COULD BECOME HARMED BY POSSIBLY HAVING CONTACT WITH A HOT STOVE OR KITCHEN EQUIPMENT (RE:KNIVES) THERE ARE CEILING TILES HANGING IN THE AFTERSCHOOL CLASS THAT COULD FALL ON CHILDREN AND POSSIBLY CAUSE HARM.
