Statement of Deficiencies

713.A.: Office of Public Health, State Fire, City Fire Approval

713.A.: Annual licensing inspections by the department, current approvals by the Office of Public Health, Office of State Fire Marshal, and city fire (if applicable), and academic approval by the department (if type III center) shall be required before the expiration of an existing license. However, if a center has documentation establishing that the center requested an inspection by the Office of Public Health or the Office of State Fire Marshal prior to the expiration of the existing license, these approvals may be submitted to the department within 90 calendar days of the date of the license renewal.

Finding:

713.A. Based on record review on 4/17/19, a current academic approval by the department was not obtained as the last approval was dated for June 30, 2018.

1707.A.1.&2.: Required Staffing - Director or Director Designee

1707.A.1.&2.: Director or Director Designee. Each center shall have a qualified director or qualified director designee.

1. The director or director designee shall be an on-site, full-time staff person at the center during the daytime hours of operation (prior to 9 p.m.). When the director is not an on-site full-time employee at the licensed location, there shall be a qualified director designee who is an on-site full-time employee at the licensed location.

2. The director or director designee shall be responsible for planning, managing, and controlling the center's daily activities, as well as responding to parental concerns and ensuring that minimum licensing requirements are met.

Finding:

1707.A.1.&2.: Based on record review on 4/17/19, the center did not have a qualified Director who is an on-site full time staff person at the center during the day time hours of operation (prior to 9:00 p.m.) and responsible for planning, managing, and controlling the center's daily activities, as well as responding to parental concerns and ensuring that minimum licensing requirements are met as evidenced by S10 stated that she sent in documentation to have S1 added as a qualified director/designee however additional information was required and never received therefore S1 was never qualified.

1901.J.&K.: Items That Can be Harmful to Children

1901.J.&K.: J. Items that can be harmful to children, such as medications, poisons, cleaning supplies and chemicals, and equipment, tools, knives and other potentially dangerous utensils, shall kept in a locked cabinet or other secure place that ensures they are inaccessible to children. K. Plastic bags, when not in use, regardless of purpose or use, shall be made inaccessible to children.

Finding:

1901.J.: Based on observation on 4/17/19, items that can be harmful to children were not kept in a locked cabinet or other secure place that ensures they are inaccessible to children as evidenced by there were 3 packages of baby wipes on the changing table accessible to the children. S1 removed the items during the walk through.

1911.I.&J.: Proper Lifting of a Child

1911.I.&J.: I. Staff members shall adhere to proper techniques for lifting a child. J. Staff members shall not lift a child by one or both arms.

Finding:

1911.I.&J.: Based on observation on 4/17/19, staff members did not adhere to proper techniques when lifting a child as evidenced by C1 was laying on his stomach in a toy house on the playground when S2 picked C1 up off the ground by his arm and raised him to a standing position.
