A criminal record clearance is not transferable from one employer to another. No staff with a criminal conviction of a felony, a plea of guilty or nolo contendere of a felony, or any offense of a violent or sexual nature, or any offense involving a juvenile victim shall be employed in a Class "A" child care center.

WHITE OUT IN THE 1 YEAR OLD CLASSROOM WAS ON A SHELF NOT LOCKED. SHAVING CREAM AND ENGINE OIL WERE IN AN UNLOCKED CLOSET IN THE 3 TO 4 YEAR OLD CLASSROOM.

5327-L: Clean of Hazards Not Met

5327.L. The center and yard shall be clean and free from hazards.
