Statement of Deficiencies

5311-A.4: Health Statement

5311.A.4. A record for each paid and non-paid staff person, including substitutes and foster grandparents shall be on file at the center. Personnel record shall include a written statement of good health signed by a physician or designee. Health statement dated within three months prior to offer of employment or within one month after date of employment is acceptable. A health statement is required every three years. Originals shall be presented upon request.

Finding:

7311.A.4 (old tag 5311.A.4.) Health records to include documentation of good health, signed by a physician or designee were not available for 2 staff.

5311-A.5: Criminal Record Check

5311.A.5. A record for each paid and non-paid staff person, including substitutes and foster grandparents shall be on file at the center. Personnel record shall include documentation of a satisfactory criminal record check, as required by R.S.15:587.1. Provider shall request this clearance prior to the employment of any center staff. A criminal record clearance is not transferable from one employer to another. No staff with a criminal conviction of a felony, a plea of guilty or nolo contendere of a felony, or any offense of a violent or sexual nature, or any offense involving a juvenile victim shall be employed in a Class "A" child care center.

Finding:

7311A.4 (old tag 5311.A.5.) Documentation of a satisfactory criminal record check, as required by Louisiana R.S. 15:587.1, was not available for 1 of 9 staff. Documentation of submission was available that the request was mailed 10/21/07 before the 12/17/07 deadline. It was returned for fingerprints, and was re-submitted .

5311-B.2: Information Extracurricular

5311.B.2. The following information shall be kept on file for therapeutic professionals and extracurricular personnel, e.g. computer instructor, dance instructor, librarian, tumble bus personnel, etc.: documentation of their presence at the facility to include:

-name; -date of visit;

7319.D (old tag)5319.D. Although meals met requirements, menu substitutions were not recorded on or near the posted menu as posted breakfast was pancakes and syrup, slice apples, and milk. Breakfast served was blueberry muffins, applesauce, and milk. Posted lunch was baked chicken, macaroni & cheese, vegetable medley, pears, and milk. Lunch served was turkey Ham, mashed potatoes and gravy, green beans, apricots, rolls, and milk.

5335-D: Master Transportation List

5335.D. Each driver or attendant shall be provided with a current master transportation list including each child's name, pick up and drop off locations, and authorized persons to whom the child may be released. Documentation shall be maintained on file at the center whether provided by center or contract.

Finding:

7335.D (old tag 5335.D.) The provider did not have documentation that the driver or attendant was provided with a current master transportation list. Transportation is provided by center.

5335-E: Attendance Record

5335.E. The driver or attendant shall maintain an attendance record for each trip. The record shall include the driver' name, the date, name of all passengers (children and adults) in the vehicle, the name of the person to whom the child was released and the time of release. Documentation shall be maintained on file at the center whether provided by center or contract.

Finding:

7335.E. (old tag 5335.E.) The transportation attendance record documentation was incomplete as it did not always include: the name of the person to whom the child was released. Often grandmother, grandfather, mother, or daddy was documented. The person's full name is required. Transportation is center provided.

5335-F: Visual Check of Vehicle

5335.F. The staff shall check the vehicle at the completion of each trip to ensure that no child is left on the vehicle. Documentation shall include the signature of the person conducting the check and the time the vehicle is checked. Documentation shall be maintained on file at the center whether provided by center or contract.

Finding:

7335.F(old tag 5335.F.) Documentation of the visual check of the vehicle was incomplete as it did not include the time the vehicle was checked.
