Finding

1509-A.8.c Based on record review: The Center's Behavior Management failed to show written documentation of it Behavior Management Policy-Time Out to include:

- i. Time out shall not be used for children under age 2.
- ii. A time out shall take place within sight of staff.
- iii. The length of each time out shall be based on the age of the child and shall not exceed 1 minute per year of age.
- iv. For children over age six, a time out may be extended beyond 1 minute per year of age, if a signed and dated statement, including a maximum time limit, from the parent granting such permission, is on file at the center.

The provider stated the center does not use the Time Out Behavior Method in the center but did not have documentation of stated policy.

1711-A-B-D-G: A. Child to staff ratios are established to ensure the safety of all children.

- B. Minimum child to staff ratios shall be met at all times.
- 1. There shall be a minimum of two staff members present at an early learning center when more than one child is present.
- 2. Only those staff members directly providing care, supervision or guidance to children shall be counted in the child to staff ratios.

1711-A-B. 1-2 Provider did not have at a minimum of 2 child care staff present at an early learning center when more than one child is present as one staff, S1, was supervising 12 children ranging in age from 10 months old to 4-years-old from 1:10pm-2:10pm. The Child/Staff ratio was met with the arrival of S2 at 2:10pm.

1711-H: Rest Time - Minimum Child to Staff Ratio

- 1. Sufficient staffing needed to satisfy child to staff ratios shall be present on the premises during rest time and available to assist as needed.
- 2. Children ages one and older may be grouped together at rest time with one staff member in each room supervising the resting children. If two rooms share a common doorway, one staff member may supervise the resting children in both rooms.
- 3. If the view of the staff supervising the children is obstructed by an object such as a low shelving unit, children shall be checked by sight by staff circulating among the resting children.

Finding:

1711-H: 1. Based upon observations: The provider did not have the required staffing present in the building during rest time to satisfy child/staff ratio as evidenced by Twelve (12) children ranging in age from 10 months to 4-years old present with one (1) staff, S1. The number of children per age range that were present in the center at nap-time included:

- 1-ten -month old infant;
- 3-one- year-old children
- 4-two- year-old children
- 3-three-year-old children
- 1-four-year-old-child

Two Staff are required to be present on the premises at nap-time to meet the child/staff ration of 12 children ranging in age from 10-months to 4-years. The Center's Child-to-Staff Ratio was met with the arrival of S2 from lunch at 2:10pm. The Staff time-sheet reflect that S2 left the center at 1:10pm on a lunch break.
