## Statement of Deficiencies

## 713.A: Office of Public Health, State Fire, City Fire approval

713.A: Current approvals by the Office of Public Health, Office of State Fire Marshal, City Fire (if applicable) and the Licensing Division shall be required before the expiration of an existing license.

#### Finding:

713.A Based on record review: Center didn't have documentation of current Fire Marshal approval. Last approval was dated 04/08/15.

#### 1103-A-E: Critical Incidents and Required Notification

1103-A-E: An early learning center shall make immediate notification to emergency personnel, law enforcement as applicable, and other appropriate agencies for the following types of critical incidents involving children in care:

- 1. death;
- 2. serious injury or illness that required medical attention;
- 3. reportable infectious diseases and conditions listed in LAC 51.II.105; and
- 4. any other significant event relating to the health, safety, or well-being of any child, including but not limited to a lost child, an emergency situation,
- fire or other structural damage, or closure of the center.
- B. The parent shall be contacted immediately following any immediate notifications made under Subsection A.

C. The Licensing Division and other appropriate agencies shall be notified via email within 24 hours of the incident.

D. The Licensing Division shall be notified by written report within 24 hours of the incident or the next business day. This written notification shall be

made on the Licensing Division?s Critical Incidents Report Form and shall contain all information requested on the form.

E. Reporting deadlines may be adjusted in the event of a natural catastrophe and/or disaster, as determined by the Department.

#### Finding:

1103-A-E Based on record review: S1 failed to notify within 24 hours of the incident the Licensing Section of the following critical incident : On 03/23/17 C11 fell while walking down the stairs and broke his arm. S1 states that his mother was called and she picked him up immediately and took him to the doctor. S1 states that she was not aware that this needed to be reported to Licensing as this was the first time anything like this has happened. S1 also failed to notify the Division of Licensing by written report within 24 hours of the incident or by the next business day. The written notification shall be made on the Licensing Division's Critical Incidents Report Form and shall contain all information requested on the form.

## 1707-C: Administrative Duties

1707-C: More than 42 Children in Care. When the number of children present at an early learning center exceeds 42, the duties of the director or director designee shall consist only of performing administrative duties or there shall be an individual present whose job duties consist solely of administrative duties and of ensuring that staff members working with children do not leave their classrooms to handle administrative duties.

#### Finding:

1707-C Based on observations: S1's duties did not consist only of administrative functions when the number of children in care exceeded 42 as there was 46 children at the center and director was performing teacher duties. S1 was observed in the classroom when specialist arrived, S6 assisted specialist until 12:30 pm and then S1 took of director duties.

## 1713-A&B&C: Supervision

Not Met

1713-A&B&C: A: Children shall be supervised at all times in the center, on the playground, on field trips, on non-vehicular excursions, and during all water activities and water play activities.

B: Children shall not be left alone in any room, (except the restroom as indicated in Subsection G of this Section or when being provided services by therapeutic professionals, as deficed in 103), outdoors, or in vehicles, even momentarily, without staff present.

C: A staff person shall be assigned to supervise specific children whose names and whereabouts that staff person shall know and with whom the staff person shall be physically present. Staff shall be able to state how many children are in their care at all times.

## Finding:

1713-A&B&C: Supervision: Children were not under supervision at all times as specialist observed two children (ages 3-4 years of age) in the breezeway/play area located outside of S1's classroom (classroom located nearest to the exiting sidewalk and street). The door of the classroom was open and the children could be heard from inside of the room. The classroom has a window facing the playarea, but this window does not allow the staff to see the children from all angles of the room. Specialist entered the breezeway through an unlocked door that leads directly to the sidewalk and out to the street, both children were observed sitting near the door and could have easily exited the door at anything. S6 states that the door was supposed to be locked.

## 1715-A.4: Criminal Background Check

1715-A.4: Staff Members. Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a fingerprint based satisfactory criminal background check

#### Finding:

1715-A.4 Based on record review: Documentation of a satisfactory fingerprint based criminal background check (CBC) was not available for 1 (S8) of 8 staff, prior to the individual(s) being present in the childcare facility (1703.A) S8's date of hire is 08/01/16. S1 states that she knows that it was completed, but that she could not locate it.

## 1723-A.&B.: CPR Certification

#### 1723-A.&B.: Infant and child CPR

Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR.

Adult CPR

Centers shall have at least one staff member on the premises and accessible to children trained in Adult CPR if there is a child eight years or older on the premises.

#### Finding:

1723-A.&B.: CPR Certification Based on record review: S1 did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in infant and child CPR. 1 (S1) of 8 staff had documentation of this certification. S1 states that some of the other staff have the certification, but she does not know where the cards are located.

## 1723-C.-D.: Pediatric First Aid

#### 1723-C.-D.:

C. Pediatric First Aid - Beginning on July 1, 2016, Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in Pediatric First Aid.

D. Certification - A copy of the certification for each such staff member shall be on-site at all times and available for inspection by the Licensing Division.

#### Finding:

1723-C.-D. Based on record review: After July 1, 2016 - S1 did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in Pediatric First Aid. 1 (S8) of 8 staff had documentation of this certification. S1 states that some of the other staff have the certification, but she does not know where the cards are located.

## 1901- G.&H.: Equipment

1901- G.&H.: All equipment used by children shall be maintained in a clean and safe condition and in good repair. Moveable equipment shall be secured and supported so that it shall not fall or tip over.

#### Finding:

1901- G.&H.: Equipment Based on observation: All of the center equipment used by children was not maintained in a clean and safe condition and in good repair.

## **1921-C: Evacuation Pack**

1921-C: The center shall have an evacuation pack, the location of which is known to all staff, that at a minimum shall contain:

- 1. a list of area emergency phone numbers;
- 2. a list of emergency contact information and emergency medical authorization for all enrolled children;
- 3. an emergency pick up form;
- 4. first aid supplies, hand sanitizer, wet wipes, and tissue;
- 5. diapers for children who are not toilet trained and plastic bags for diapers;
- 6. a battery powered flashlight and radio and batteries;
- 7. food for children under the age of 4, including infant food and formula; and
- 8. disposable cups and bottled water.

## Finding:

1921-C Based on observations: Food observed in evacuation pack expired Aug 2016. S1 states that she will get items replaced. Also observed water jugs leaking.
