Statement of Deficiencies

1713-A&B&C: Supervision Not Met

1713-A&B&C:

- A: Children shall be supervised at all times in the center, on the playground, on field trips, on non-vehicular excursions, and during all water activities and water play activities.
- B: Children shall not be left alone in any room, (except the restroom as indicated in Subsection G), outdoors, or in vehicles, even momentarily, without staff present.
- C: A staff person shall be assigned to supervise specific children whose names and whereabouts that staff person shall know and with whom the staff person shall be physically present. Staff shall be able to state how many children are in their care at all times.

Finding

1713-A&B&C: Based on observations: Children were not under supervision at all times as Specialist observed that S6 was sleeping and was observed with her head down, eyes closed, and could be heard snoring while supervising a group of children. Specialist observed S6 asleep for approximately 30 seconds while solely responsible for the supervision of a group of 8 two year olds. Specialist advised S1 to ensure that staff remain awake while supervising a group of children including at nap time.

1713-E&F: Supervision Participation

Not Met

1713-E&F:

- E: While supervising a group of children, staff shall devote their time to supervising the children, meeting the needs of the children, and participating with them in their activities.
- F: Staff duties that include cooking, housekeeping or administrative functions shall not interfere with the supervision of children.

Finding:

1713-E&F: Based on observations and interviews: While supervising a group of children, childcare staff did not devote their time to supervision of the children, meeting the needs of the children, and in participation with the children in their activities. Specialist observed S5 using her phone while supervising a group of children. S5 stated that she was contacting someone to pick up her children. Specialist also observed S4 using her cell phone while solely responsible for the supervision of a group of 5 one year olds. S4 stated she was playing a game. Specialist advised S1 that even during nap time, staff must still monitor children.

1715-A.5: State Central Registry

Not Met

1715-A.5: Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a current, completed state central registry disclosure form indicating no justified (valid) finding of abuse or neglect by the DCFS, or a current determination from the DCFS indicating that the individual does not pose a risk to children.

Finding:

1715-A.5 Based on observations/record review: Provider failed to have documentation of a completed state central registry disclosure form (SCR 1)prior to an individual being present in or providing services to the center on site and available for review at the center(1705.A-B). 2 of 8 staff, S4 and S5 failed to have documentation of the completed form prior to being present in the center. Staff were on the premises on May 15, 2017 failed to have documentation of the completed form. Staff were on the premises as observed by the licensing specialist. S4 went to her car and provided an incomplete SCR1 form that did not indicate whether or not she had a valid finding ans was not signed by a representative of the center. S5's SCR1 on file was not dated by either S5 or a center representative and the center information at the top of the form was not completed.

1719-A.-B.: Orientation Training

Not Met

1719-A.-B.: Within seven calendar days of date of hire, and prior to assuming sole responsibility for any children, each staff member shall receive orientation to the policies and practices of the center that at a minimum shall include:

- child abuse identification and reporting;
- 2. emergency preparation;
- 3. licensing regulations; and
- 4. safe sleep practices,

Within 30 calendar days of date of hire, each staff member shall receive orientation to the additional policies and practices of the center that at a minimum shall include:

- 1. child development;
- 2. child guidance;
- 3. learning activities;
- 4. health and safety;
- shaken baby prevention;

Statement of Deficiencies

Finding:

1719-A.-B. Based on record review: Provider lacked documentation that 3 of 8 staff, S4, S5, and S8, received orientation of the policies and procedures of the center within 7 days of hire and prior to assuming sole responsibility for any children. Provider lacked documentation that 2 of 8 staff, S5 and S8 received additional orientation within thirty days of date of hire.

1723-A.&B.: CPR Certification Not Met

1723-A.&B.: A - Infant and child CPR - Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR.

B - Adult CPR - Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in adult CPR.

Finding:

1723-A.&B: Based on record review and observations: The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in infant and child CPR. 3 of 8 staff had documentation of this certification. The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in adult CPR. 3 of 8 staff had documentation of this certification.

1723-C.-D.: Pediatric First Aid Not Met

1723-C.-D.:

- C. Pediatric First Aid Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in Pediatric First Aid.
- D. Certification A copy of the certification for each such staff member shall be on-site at all times and available for inspection by the Licensing Division.

Finding:

1723-C.-D: Based on record review and observations: The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in Pediatric First Aid. 3 of 8 staff had documentation of this certification.

1907-E.2: Cribs Free of Toys and Other Soft or Loose Bedding

Not Met

1907-E.2: Cribs shall be free of toys and other soft or loose bedding, including comforters, blankets, sheets, bumper pads, pillows, stuffed animals and wedges when the child is in the crib.

Finding:

1907-E.2 Based on observations: The center's cribs were not free of toys or other soft or loose bedding (including blankets) while the child was in the crib as evidenced by Specialist observed one infant sleeping in a crib with a loose blanket. S1 directed staff to correct.
