S1 and S2 did not maintain documentation of a daily attendance record for Directors/director designee, to include the time of arrival and departure. S2 states that because she and S1 are salaried, they don't document arrival and departure. S2 was advised the the times have to be documented.

1715-A.4: Staff Members. Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a fingerprint based satisfactory criminal background check

Finding:

1715-A.4 Based on record review: Documentation of a satisfactory fingerprint based criminal background check (CBC) was not available for 2 of 16 staff, prior to the individual(s) being present in the childcare facility (1703.A) S11 date of hire is 03/20/17 and S12 date of hire is 03/31/17. Based on review of S11's folder a receipt for criminal background check (CBC) submission and certification of no prohibited crimes was completed on 01/25/17 and receipt on 03/20/17, and S12 a receipt for criminal background check (CBC) submission and certification of no prohibited crimes was completed on 03/31/17 and there was no receipt observed in the record, however per the CBC waiver distribution letter dated 01/10/17, the waiver was terminated as of 01/31/17. S11's CBC was received on 03/23/17 and S12's CBC was received on 04/01/17.

1915-A: Health Services - Observation

1915-A: Upon arrival at the center, the physical condition of each child shall be observed for possible signs of illness, infections, bruises or injuries, and when something is observed, it shall be documented and such documentation shall include an explanation from the parent or child.

Finding:

1915-A Based on record review: Staff did not document results including explanation from the parent or child. Observation reports dated 05/15/17-05/19/17 for C11, shows that on 05/15/17, 05/16/17 a bump was observed on C11's right temple and mark on eyebrow and middle forehead, red spot on lip on 05/18/17, and scratch on ride side of face on 05/19/17, observation reports dated 05/22/17-05/26/17 for C12 shows that on 05/22/17 C12 had a scratch on right eye, forehead and check, on 05/23/17 and 05/24/17 C12 had a scratch on eye, 05/25/17 C12 had a bruise on left leg and on 05/26/17 C12 had a scratch on eye and forehead, there were no explanations given for any of the documented injuries.
