1507.A.: A daily attendance record for children shall be maintained that shall:

- 1. include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released;
- 2. accurately reflect children on the center premises at any given time; and
- 3. be used to sign in and out if a child leaves and returns to the center during the day.

#### Finding:

1507.A.: Based on observation/record review on 6/7/19, the center's daily attendance record for children did not accurately reflect the children on the child care premises at any given time as 23 children were present and 20 children were signed in on the log. S1 was able to verify the three children that were not sign in during the center visit.

# 1711.A.&B.&D.&G.: Child to Staff Ratio

**Not Met** 

1711.A.&B.&D.&G.: A. Child to staff ratios are established to ensure the safety of all children.

- B. Minimum child to staff ratios shall be met at all times.
- 1. There shall be a minimum of two staff members present at an early learning center when more than one child is present.
- Only those staff members directly providing care, supervision or guidance to children shall be counted in the child to staff ratios.
- D. Minimum Child to Staff Ratios for Type II and Type III centers:

1711.B.1.: Based on record review on 6/7/19 at 3:27 pm, S1 did not have at a minimum of 2 child care staff present at an early learning center when more than one child is present as one staff, S1, was supervising 5 children ages (C1-4, C2-2, C3-1, C4-4mths, and C5-4). LS observed S1 was signed in at 6:22 am, and supervised C1 and C2 at 6:43 am, C5 at 7:09 am, C3 at 7:13 am, and C4 at 7:20 am, before the next staff member, S2, arrived at 7:24 am.

#### 1911.E.: Daily Reports for Infants

1911.E.: Daily Reports for Infants. Written reports that include the liquid intake, food intake, disposition, bowel movements and eating and sleeping patterns shall be given to the parents of infants on a daily basis. Reports shall be kept current throughout the day.

#### Finding:

1911.E.: Based on record review on 6/7/19 at 3:09 pm, S1 lacked a daily written report that was kept current throughout the day for 5 of 5 infants as LS observed S3 failed to document any information for 2 out of 5 children and only documented the following:

C4's first name and 8:00 am with no additional information

C6's first name and 8:00 am diaper change

C7's first name and 9:00 am diaper change/bowel movement

## 2101.A.9.: Vehicle - Safety Inspection
