# Statement of Deficiencies

## 1507.A.: Daily Attendance Records - Children

1507.A.: A daily attendance record for children shall be maintained that shall:

- 1. include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released;
- 2. accurately reflect children on the center premises at any given time; and
- 3. be used to sign in and out if a child leaves and returns to the center during the day.

#### Finding:

#### 1507.A. Based on record review:

The daily attendance log for children did not include the time of arrival and departure of each child and the name of the person to whom the child was released. The daily attendance log for children on 6/2/19, had 8 children not signed out. The attendance log on 6/4/19, had one child not signed out and one child did not show the name of the person to whom the child was released. The attendance log on 6/5/19, had 7 children not signed out, one child not signed out, one child not signed out), 3 children did not show the name of the person to whom the children were released. The attendance log on 6/6/19, had 4 children not signed out and one child did not show the name of the person to whom the children were released.

## 1509.A.7.: Parental Involvement Policy

#### 1509.A.7.: Parental Involvement Policy

Parents shall be offered a minimum of two opportunities for involvement each year, which may include but are not limited to, an open house, parent education session, parent and staff conference, family pot luck dinner, holiday party or parent or grandparent's day.

#### Finding:

1509.A.7. Based on record review: There was no documentation of a policy offering Parents a minimum of two opportunities for involvement each year, which may include but are not limited to, an open house, parent education session, parent and staff conference, family pot luck dinner, holiday party or parent or grandparent's day. This information was reviewed at 1;23 pm.

### 1907.C.2.: Sleeping Arrangements Labeled

1907.C.2.: Individual sleeping accommodations shall be assigned to a child on a permanent basis and labeled, unless the cots or mats are sanitized daily.

#### Finding:

1907.C.2. Based on observations: Cots or mats were not assigned to children on a permanent basis as they were not labeled. The Specialist observed at 12:18 pm, that cots were not labeled.

#### 1921.A.: Emergency Preparedness and Evacuation Planning

1921.A.: Emergency and Evacuation Plan. The director shall consult with appropriate state and local authorities and shall establish and follow a written multi-hazard emergency and evacuation plan to protect children in the event of emergencies that at a minimum shall:

1. address any potential disaster related to the area in which the center is located;

2. include procedures for sheltering in place, lockdown and evacuation to a pre-determined site for potential threats to the safety, health and well-being of children in care;

3. include specific procedures for handling infants through two year olds, including food and formula;

4. include specific procedures for handling children with special needs, including the evacuation and transportation of children in wheelchairs;

5. include a system to account for all children;

6. include a system, and a back-up system, for contacting parents and authorized third party release caretakers;

7. include a system to reunite children and parents following an emergency;

8. include procedures for providing information about the emergency plan to parents at the time of enrollment and when changes occur;

9. be reviewed annually for accuracy and updated as changes occur; and

10. be reviewed with all staff at least once per year.

11. practice drills shall be conducted at least twice per year to include all children and shall be documented.

## Finding:

1921.A. Based on record review: There was no documentation of a written Emergency and Evacuation Plan that included all potential diasters related to the area. The plan did include procedures for lockdown and tornados. This information was reviewed at 1:38 pm.

## 1921.C.: Evacuation Pack

1921.C.: Evacuation Pack

The center shall have an evacuation pack, the location of which is known to all staff, that at a minimum shall contain:

- 1. a list of area emergency phone numbers;
- 2. a list of emergency contact information and emergency medical authorization for all enrolled children;
- 3. an emergency pick up form;
- 4. first aid supplies, hand sanitizer, wet wipes, and tissue;
- 5. diapers for children who are not toilet trained and plastic bags for diapers;
- 6. a battery powered flashlight and radio and batteries or a crank flashlight and crank radio; and
- 7. disposable cups and bottled water.

## Finding:

1921.C. Based on observations: The Specialist did not observe in the evacuation pack the following: a list of area emergency numbers, first aid supplies, disposable cups and bottled water. This was observed at 1:40 pm.
