1509-A.1 Based on record review/interviews: Although mandated reporters, staff did not report suspected abuse/neglect of a child to the Child Protection Statewide Hotline as S13 failed to report suspected abuse and neglect. S13 written statement stated that she witnessed S11 pluck C1 and other children in 2 year old classroom names are unknown on the hand on 6/22/17 and another date unknown as she was put them in timeout. S13 stated that she did not report the suspected abuse or neglect because she thought that she only needed to report if the children where hurt. S13 was trained on Child Abuse/reporting on 1/12/17.

The behavior management policy shall prohibit children from being subject to any of the following:

- i. physical or corporal punishment which includes but is not limited to yelling, slapping, spanking, yanking, shaking, pinching, exposure to extreme temperatures or other measures producing physical pain, putting anything in the mouth of a child, requiring a child to exercise, or placing a child in an uncomfortable position.
- ii. verbal abuse, which includes but is not limited to using offensive or profane language, telling a child to "shut up", or making derogatory remarks about children or family members of children in the presence of children;
- iii. the threat of a prohibited action even if there is no intent to follow through with the threat;
- iv. being disciplined by another child;
- v. being bullied by another child;
- vi. being deprived of food or beverages;
- vii. being restrained by devices such as high chairs or feeding tables for disciplinary purposes; and
- viii. having active play time withheld for disciplinary purposes, except timeout may be used during active play time for an infraction incurred during the playtime.

1509-A.8. a-b Based on record review/interview(s): S11 used a prohibited method of discipline as C1, a child was subject to physical punishment, as S11 used a prohibited method of discipline by "Plucking" C1 and other children whose names are unknown on the hand in the 2 year old classroom on 6/22/17 and another unknown date. S11 was terminated for violating the center's policy.
