S1 stated S2 failed to notify her, Licensing, and the other appropriate agencies with 24 hrs. S1 stated she was notified by O2 on 6/29/18 at 9:54 pm about the incident. S1 stated she notified and submitted a critical incident report to Licensing on 7/2/18 via email and resubmitted on 7/3/18. S1 also notified Child Welfare on 7/3/18.

On 6/28/18, S2 was notified about an incident regarding C1 inappropriately touching C2's private area. Per S1's statement, C1 informed her that the incident occurred while S3 was in the classroom on the cellphone during naptime, and C2 informed S1 that the incident occurred while S9 was in the classroom on the cellphone playing candy crush.
