1507-A: A daily attendance record for children shall be maintained that shall:

- 1. include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released;
- 2. accurately reflect children on the center premises at any given time; and
- 3. be used to sign in and out if a child leaves and returns to the center during the day.

Finding:

1507-A Based on record review:

The daily attendance log for children did not include either the arrival or departure time of each child. The center also has preprinted names of the person to whom the child was released on the attendance form. Specialist was not able to determine if the preprinted names of the entity was actually the person to whom the child was released to on each day as no current signature or initials were documented on the form. documentation of a departure time was not documented for the following dates: 6/11/2018(1 of 20 children did not have a sign out), 6/12/2018(3 of 23, no departure time), 6/13/2018(6 of 22, no departure times), 6/16/2018(1 of 23), 7/12/2018(1 of 26), 7/13/2018(1 of 26 no arrival time), 7/17/2018(1 of 26 no departure), 7/20/2018(1 of 20 no departure) and 7/23/2018(1 of 17 no departure).

1901-C: End-of-Day Check

1901-C: The entire center and play yard shall be checked after the last child departs to ensure that no child is left at the center and this check shall be documented. Documentation shall include date, time of visual check, and signature of the staff conducting the visual check.

Finding:

1901-C Based on record review:

The Provider did not document that the entire center and play yard is checked after the last child departs to ensure that no child is left unattended at the center on June 8, 2018 as no information was documented for that day. The centers end of the day check for 7/24/2018 was prematurely documented as the time (6:00pm) and signature(Michelle King-verified by S1) had already been completed at the time of specialist review of documentation.
