Beginning July 1, 2015, Type I center staff shall obtain a minimum of 6 clock hours of such training annually. Beginning July 1, 2016, Type I center staff shall obtain a minimum of 9 clock hours of such training annually. Beginning July 1, 2017, Type I center staff shall obtain a minimum of 12 clock hours of such training annually.

Training shall be conducted by trainers approved by the Licensing Division.

B. These Hours are in addition to the 3 hours required for health and safety.

C. Copies of certificates of completion or attendance records shall be maintained at the center and available for inspection by the Licensing Division upon request.
