The child had to wear a cast for a few weeks because of the injury, Per interview with the provider the parent notified them on the next day of that the child's foot was fractured in three places and the provider failed to notify child care licensing. (2)The provider had a one year old child that was standing up in a high chair and fell to the floor hitting his head on July 22, 2011. (3) -Any child leaving the center unsupervised [the facility had a two year old child (C-1) that ran out of the facility in the Month of July 2011 (exact date unknown because the provider failed to document the incident) and the provider failed to contact child care licensing within the mandated 24 hour time period. ## 5317-A: Direct Supervision

5317.A. Children shall be under direct supervision at all times including naptime. Children shall never be left alone in any room or outdoors without a staff present. Children, excluding infants, may be grouped together at naptime with one staff supervising the children sleeping. All children sleeping shall be in the sight of the naptime worker.

#### Finding:

\*\*\*\*\*NEW 7317.A (old tag 5317.A. Children were not under direct supervision at all times as evidenced by the provider had three separate incidents to occur to children that were enrolled in the facility in the Month of July 2011; one incident involved a two year old child (C-1) that ran out of the front door of facility and onto the ramp of the three year old building (exact date unknown), the second incident occurred on July 22, 2011 in which a one year old child (C-2) was standing up in a high chair and fell onto the floor injuring his head, and the third incident involved a three year old child(C-3) that sustained three fractures to one of his feet and the staff failed to observe that the child had injured himself, the father observed the child limping when he picked him up from the day-care on July 12, 2011.

The Provider did not have documentation of immediate notification to the parent or designated person when the following occurred to a child: [a child (C-1) running out of the facility unsupervised & a Child injuring his foot exact date uncertain think it may have occurred on July 12, 2011]. Incident occurred at [unknown time (AM Hours) & Unknown Time)] on [unknown date in July 2011(C-1) & (on July 12, 2011(C-3)] and the parent was notified verbally at [pick-up for (C-1) & never notified (for C-3) parent observed the child limping when the child was picked up at 2:25pm],.7321.K (old tag 5321.K. The provider's documentation of incidents of injuries and accidents was incomplete as the following was not noted: [location, description of occurrence for (C-2)]. Date of incident was July 22, 2011, the provider failed to document on the accident report that the child (C-2) was standing up in a high chair when he felled to the floor and hit his head, they only listed that the child fell and hit his head on the floor, Per interview with the parent they were not made aware of the actual circumstances of the child's fall until the next day
