# 1515-A.2: Emergency Medical Treatment

1515-A.2: Written authorization signed and dated by the parent to secure emergency medical treatment.

#### Finding:

1515-A.2 Based on record review: 1 of 6 Children's records (C5) lacked a signed and dated parental authorization to secure emergency medical treatment.

### 1715-A.4: Criminal Background Check

1715-A.4: Staff Members. Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a fingerprint based satisfactory criminal background check

#### Finding:

1715-A.4 Based on record review: Documentation of a satisfactory fingerprint based criminal background check (CBC) was not available for 2 of 5 staff, prior to the individual(s) being present in the childcare facility(1703.A). First day school for the 2017-2018 school year was 09/05/2017. S4's date of hire is 07/31/2017. S4 was on premises on 09/05/2017, 09/06/2017, 09/07/2017, 09/08/2017 and 09/11/2017. S5's date of hire is 09/01/2017. S5 was on premises on 09/05/2017, 09/07/2017, 09/08/2017 and 09/11/2017. Specialist observed S5 leave premises at 12:00pm on 09/11/2017. Specialist observed S4 leave premises at 1:00pm on 09/11/2017.

### 1715-A.5: State Central Registry

1715-A.5: Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a current, completed state central registry disclosure form indicating no justified (valid) finding of abuse or neglect by the DCFS, or a current determination from the DCFS indicating that the individual does not pose a risk to children.

#### Finding:

1715-A.5 Based on record review:

Provider failed to have documentation of a completed state central registry disclosure form (SCR 1)prior to an individual being present in or providing services to the center on site and available for review at the center(1705.A). 1 of 5 staff, S5 failed to have documentation of the completed form. Staff were on the premises on 09/05/2017, 09/06/2017, 09/07/2017, 09/08/2017 and 09/11/2017 as verified by staff attendance logs. S5 left premises before a current SCR1 form could be completed.

## 1723-A.&B.: CPR Certification

1723-A.&B.: Infant and child CPR

Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR.

Adult CPR

Centers shall have at least one staff member on the premises and accessible to children trained in Adult CPR if there is a child eight years or older on the premises.

#### Finding:

1723-A & B. Based on observations/record review: The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in infant and child CPR. 2 of 5 staff had documentation of this certification. At 12:00pm, S5 left premises allowing the center to have at lease 50% of all staff on the premises certified.

#### 1723-C.-D.: Pediatric First Aid

1723-C.-D.: C. Pediatric First Aid - Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in Pediatric First Aid.

D. Certification - A copy of the certification for each such staff member shall be on-site at all times and available for inspection by the Licensing Division.

Based on observations/record review: After July 1, 2016 - The Provider did not have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current

1919-A&B: All meals and snacks provided by the center, and their preparation, service and storage, shall meet the requirements for meals of the U.S. Department of Agriculture (USDA) Child and Adult Care Food Program (CACFP) and 7 C.F.R. 226.20 and the Louisiana Sanitary Code, Title 51, Part XXIII, found at LAC 51:XXXIII. For the current CACFP meal patterns, contact the Louisiana Department of Education, Division of Nutrition Support.

The weekly menu shall:

- 1. be planned for each day of the week and list the specific food items served;
- be prominently posted by the first day of each week and remain <b>posted</b> throughout the week; and 2.
- have substitutions or additions posted on or near the menu. 3.

#### Finding:

The Current weekly menu listing specific food items served for each day of the week was not prominently posted by the first day of each week and remain posted throughout the week.
