Finding:

1715-A.4 Based on record review/interview: The provider did not have documentation of a fingerprint based satisfactory criminal background check from Louisiana State Police for the following staff: S1, S2, S3, S4, S5, S6 and S7 prior to the individuals being present in the early learning center. Specialist observed S2-S6 present on the early learning center premises during the licensing inspection. Per statement from S8, S1, who was not present during the licensing inspection, is still employed at the center.
