5315.A. Child/staff ratios are established to ensure the safety of all children. Only those staff members directly involved in child care and supervision shall be considered in assessing child/staff ratio. Child/staff ratios shall be met at all times as the number of children supervised by one staff person shall not exceed the ratios as indicated below; however, there shall always be a minimum of two child care staff present during hours of operation when children are present:

Ages of Children	Child/Staff Ratio
Infants under 12 months	5:1
One year old	7:1
Two year old	11:1
Three year old	13:1
Four year old	15:1
Five year old	19:1
Six year old and up	23:1

An average of the child/staff ratio may be applied to mixed groups of children ages two, three, four, and five. Ratios for children under two or over five years old are excluded from averaging. When a mixed group includes children less than two years of age, the age of the youngest child determines the ratio for the group to which the youngest child is assigned. When a mixed group includes children both older and younger than six years old and older, the ages of the children less than six determine the ratio for the group. During naptime, required staffing shall be present in the center to satisfy child/ staff ratios.

## Finding:

7315.A. (OLD TAG #5315.A.) The Provider did not meet the required child to staff ratio for children of the following ages:

0N 9-24-09, UPON SPECIALIST'S ARRIVAL AT 8:15 AM THE CHILD/STAFF RATIOS WERE NOT MET IN THE 0 TO 1 YEAR OLD CLASSROOM. SECOND STAFF ARRIVED IN THAT CLASSROOM AT 8:30 AM. ACCORDING TO STAFF DAILY ATTENDANCE, THIS SECOND STAFF USUALLY ARRIVES AT 8:45 AM.

11 children age 0-1 (4-0's & 7-1's) with 1 staff. The required ratio for children age infant under 12 months is 5 children per 1 staff.

Others on the premises meeting ratio as follows:

7 children age 1 with 1 staff.

5 children age 2 with 1 staff.

10 children age 3-4 with 1 staff.

ON 9-25-09, UPON SPECIALIST'S ARRIVAL AT THE CENTER AT 8:15 AM, CHILD/STAFF RATIOS WERE NOT MET AS FOLLOWS: 17 children ages 1 - 4 (2-1's; 7-3's; & 8-4's) with 1 staff. The required ratio for children age 1 is 7 children per 1 staff. 2 Staff were needed in this room. 16 children ages 0-1 (3-0's and 13-1's) with 2 staff. The required ratio for children age infants is 5 children per 1 staff, and for children age 1 the required ratio is 7 children per 1 staff. 3 Staff were needed.

5305.H. A daily attendance record for children, completed by the parent or center staff, including the time of arrival and departure of each child and the name of the person to whom the child was released, shall be maintained. This record shall accurately reflect the children on the child care premises at any given time. If the record is completed by center staff, that individual shall write the first and last name of the person to whom the child was released and sign his/her own name. Children who leave and return to the center during the day shall be signed in/out. A computerized sign in/out procedure is acceptable if the record accurately reflects the time of arrival and departure as well as the name of the person to whom the child was released.

# Finding:

7305.H. (OLD TAG #5305.H.) The center's daily attendance record for children did not accurately reflect the children on the child care premises at any given time as 33 children were present and 27children were signed in on the log.

7305.H. (OLD TAG #5305.H.) Center staff completed the children's daily attendance record and the record did not include last name to whom child was released. IN THE 1 YEAR OLD ROOM "TO WHOM RELEASED" WAS NOT DOCUMENTED DURING THE MONTH OF SEPTEMBER 09, WHEN STAFF SIGNED OUT CHILDREN.

THERE OTHER ACCIDENTS IN WHICH CHILDREN HAD INJURIES TO THE HEAD AND THE PARENTS WERE NOT IMMEDIATELY NOTIFIED.

### 5327-L: Clean of Hazards

5327.L. The center and yard shall be clean and free from hazards.

### Finding:

7327.L. (OLD TAG #5327.L.) The center was not free of hazards as: THERE WERE TWO CHILDREN (AN 11 MONTH OLD AND A 1 YEAR OLD) OBSERVED SITTING IN HIGH CHAIRS WITH OUT BEING RESTRAINED IN SAFETY STRAPS. THESE CHILDREN WERE CAPABLE OF CLIMBING OUT WHICH COULD CAUSE INJURY. ONE CHILD HAD HIS FOOT ON THE SEAT WITH HIS KNEE UP WHILE SITTING.
