The program shall provide time and materials for both vigorous and quiet activities for children to share or to be alone, indoor and outdoor play, and rest. Regular time shall be allowed for routines such as washing, lunch, rest, snacks and putting away toys. Active and quiet periods shall be alternated so as to guard against over-stimulation of the child.

7306.B. (OLD TAG #5306.B.) The schedule of daily activities allowing for flexibility and change were not posted.

5311-A.2: Reference Checks

5311.A.2. A record for each paid and non-paid staff person, including substitutes and foster grandparents shall be on file at the center. Personnel record shall include documentation of three current, positive reference checks or telephone notes signed and dated. These references shall be obtained from persons not related to the employee.

7311.A.2. (OLD TAG #5311.A.2.) Documentation of three current, positive non related reference checks or telephone notes signed and dated was not available for staff: DOH 8-27-09 & DOH 8-27-09

5311-A.3: Job Descriptions

5311.A.3. A record for each paid and non-paid staff person, including substitutes and foster grandparents shall be on file at the center. Personnel record shall include written job descriptions for every position at the center.

5319-D: Posted Menu

5319.D. Current weekly menus for meals and snacks listing specific food items served shall be prominently posted. Menu substitutions shall be recorded on or near the posted menu.

7319.D. (OLD TAG #5319.D.) The current weekly menu listing specific food items served for meals and snacks was not prominently posted. PROVIDER HAS 3 MEALS FOR EACH DAY POSTED ON A CHALK BOARD, BUT DOES NOT HAVE A WEEKLY MENU.

5319-M: Drinking Water

5319.M. Drinking water shall be available indoors and outdoors to all children. Drinking water shall be offered at least once between meals and snacks to all children. Water shall be given to infants only with written instructions from parents.

Finding:

7319.M. (OLD TAG #5319.M.) Children were not offered drinking water at least once between meals and snacks. Specialist observed THE 3 YEAR OLD CLASSROOM WAS NOT OFFERED WATER BETWEEN BREAKFAST AND LUNCH.

5321-K: Incidents and Accidents

5321.K. Incidents, injuries and accidents shall be documented. Documentation shall include name of child, date and time of incident, location where incident took place, description of how incident occurred, part of body involved, and actions taken. Documentation of all incidents/injuries/accidents shall include time of parental notification and signature of person notifying the parent. 5325.W. Toy chests with attached lids are prohibited.

7325.W. (OLD TAG #5325.W.) A toy chest with an attached lid was being used in the HALL. CHILDREN WALK THROUGH THE HALL TO GET TO THE BATHROOM.

5327-A: Locked Harmful Substances and Equipment

5327.A. Prescription and over-the-counter medications, poisons, cleaning supplies, harmful chemicals, equipment, tools and any substance with a warning label stating it is harmful or that it should be kept out of the reach of children, shall be locked away from and inaccessible to children. Whether a cabinet or an entire room, the storage area shall be locked.

Finding:

7327.A. (OLD TAG #5327.A.) Prescription and over-the counter medications, poisons, cleaning supplies, harmful chemicals, equipment, tools, and any substance with a warning label stating it is harmful to or that it should be kept out of the reach of children were not locked away from children as evidenced by:

INFANT ROOM - *CARPET FRESHNER, DISINFECTANT SPRAY, SUPER ODOR ILLIMINATOR AND A SOLUTION IN A SPRAY BOTTLE WERE ON THE FLOOR IN THE SPACE UNDER THE SINK. THIS SPACE WAS NOT LOCKED. 3 YEAR CLASSROOM - IN A MEDICINE CABINET ON THE WALL WERE 2 CANS OF AIR FRESHENER AND A TUBE OF BOUDREAUX'S BUTT PASTE.

5327-H: Strings and Cords

5327.H. Strings and cords (such as those found on window coverings) shall not be within the reach of children.

Finding:

7327.H. (OLD TAG #5327.H.) Strings and cords were within reach of children as: INFANT ROOM - THERE IS A VACUUM ON THE FLOOR WITH AN ELECTRIC CORD WITHIN CHILDREN'S REACH. ONE YEAR OLD ROOM - THERE IS A TV ON A CART WITH AN ELECTRIC CORD ON TOP OF THE CART. THE CART IS IN THE DOORWAY TO THE 1 YEAR OLD CLASSROOM AND A CHILD COULD WALK INTO THE NEXT ROOM AND HAVE ACCESS TO THE ELECTRIC CORD. 2 YEAR CLASSROOM - THERE IS A DISCO BALL AND A RADIO WITH ELECTRIC CORDS ON THE DESK WITHIN CHILDREN'S REACH.,

HAZARD. 3-4 YEAR CLASSROOM - THERE IS A FLORESCENT LIGHT & FIXTURES ON THE WINDOW SILL WITH THE CORD WRAPPED AROUND IT. THE CORD PRESENTS A STRANGLING HAZARD AND THE LIGHT FIXTURES COULD CAUSE A CUTTIN HAZARD IF IT FALL ON THE FLOOR AND BREAKS. ** THERE IS ALSO COTTON STRING ON THAT WINDOW SILL THAT COULD CAUSE A STRANGLING HAZARD. PLAYGROUND:

THERE IS A BUCKED WITH WATER AGAINST THE BUILDING TO THE RIGHT OF THE EXIT FROM THE 3 YEAR OLD CLASSROOM.

THERE IS A L.T. SWING THAT HAD WATER IN IT AND THE SAFETY STRAP WAS WET AND MILDEWING.

THERE IS A ROUND TABLE WITH A CARD OR PRESS BOARD BOTTOM THAT IS COMING UNGLUED. THIS IS A GOOD PLACE FOR HARMFUL INSECTS TO HIDE AND IT IS WITHIN CHILDREN'S REACH.

THERE IS A CHAIN WITH A ROPE LOOP ATTACHED. IT IS HANGING ON THE BUIDLING NEXT TO THE BACK GATE FROM THE PLAYGROUND. THIS COULD PRESENT A HANGING HAZARD.

ON THE BOTTOM OF THE SHED SOME METAL HAS TORN OFF LEAVING SHARP EDGES THAT COULD CUT A CHILD. ON THE RIGHT SIDE OF THIS SHED, AN ALUMINUM SHEET IS NOT SECURED LEAVING A SHARP EDGE THAT COULD HARM THE CHILDREN. THERE IS A BORDER AROUND THE OUTSIDE TOYS/EQUIPMENT. THE SLIDES AND CLIMBERS WERE NEXT TO THE THE WOODEN BORDER, AND IF A CHILD FELL FROM THE SLIDE OR CLIMBER ON TO THE BORDER, IT COULD CAUSE HARM TO THE CHILD.

5327-P: Visual Check of Center

5327.P. The entire center shall be checked after the last child departs to ensure that no child is left unattended at the center. Documentation shall include date, time, and signature of staff conducting the visual check.

Finding:

7327.P. (OLD TAG #5327.P.) The Provider did not document that the entire center is checked at the end of the day to ensure that no child is left unattended at the center. THE LAST DOCUMENTED VISUAL CHECK WAS DATED 9/21/09.
