Not Met

1917.C.: C. All medication shall be sent to the center in its original container, shall not have an expired date, and shall be clearly labeled with the name of the child to ensure that medication is for individual use only.

Finding:

1917.C. Based on record review at 1:30 p.m., S1 failed to have a current Epinephrine Injection on file for C2, three-years-old. The Epinephrine Injection on file for C2 has an expiration of 5/2022.

Corrective Action Plan: Effective 10/10/2022, S1 stated a calendar reminder will be documented with the medication expirations so a request for updated prescriptions can be requested and kept on file, to ensure compliance with this regulation.

1917.K.: Emergency Medication Plan and Records

Not Met

1917.K.: Emergency Medications

- 1. Children who require emergency medications, such as an EpiPen or Benadryl, shall have a written plan of action that shall be updated as changes occur or at least every six months, and shall include:
- a. method of administration:
- b. symptoms that indicate the need for the medication;
- c. actions to take once symptoms occur;
- d. description of how to use the medication; and e. signature of parent and date of signature.
- 2. Medication administration records for emergency medication shall be maintained and include the following:
- a. symptoms that indicated the need for the medication;
- b. actions taken once symptoms occurred;
- c. description of how medication was administered;
- d. signature of administering staff member; and
- e. phone contact with the parent after administering emergency medication.

Finding:

1917.K.: Based on record review at 1:30 p.m., the written plan of action for C1, two-years-old, and C2, three-years-old, failed to be updated at least every six months. Specialist observed C1's written plan of action for Epinephrine Injection was signed and dated 11/12/2021 and needed to be updated no later than 5/2022. C2's Epinephrine Injection and Diphenhydramine written plan of care was signed and dated on 10/29/2021 and needed to be updated no later than 4/2022.

Corrective Action Plan: Effective 10/10/2022, S1 stated a calendar reminder will be documented with the expiration date for the medication written plan of care so it can be requested to be updated and kept on file, to ensure compliance with this regulation.

1919.D.2.: Food Service and Nutrition - Choking Hazards

Not Met

1919.D.2.: Children under age 4 shall not have foods that are implicated in choking incidents. Examples of these foods include but are not limited to: whole hot dogs, hot dogs sliced in rounds, raw carrot rounds, whole grapes, hard candy, nuts, seeds, raw peas, hard pretzels, chips, peanuts, popcorn, marshmallows, spoonsful of peanut butter, and chunks of meat larger than what can be swallowed whole.

Finding:

1919.D.2.: Based on observation at 2:10 p.m., S1 served food that is implicated in choking incidents to children under age four. Specialist observed whole vienna sausages served to four 1-year-old children in S3's classroom.

Corrective Action Plan: Effective 10/10/2022, S1 stated she will review all food items that are implicated in choking hazards and remove from center menu. All items that cannot be served whole or in rounds will be cut in half, prior to being served, to ensure compliance with this regulation.

1919-D.3.&4.: Food Service and Nutrition - Reasonable Time and Food Served

1919-D.3.&4.: 3. Children shall be allowed a reasonable time to eat each meal and snack. Children shall not be forced to finish all their food.

4. Food shall be given to children on individual plates, cups, napkins, or paper towels, as appropriate, and individual utensils shall be provided, as appropriate.

1919.D.4.: Based on observation at 2:10 p.m., S1 served four 1-year-old children vienna sausages in their hands with no individual cups, plates, or napkins as appropriate. S1 provided individual cups for the children to hold their sausages.
