1507.A.: A daily attendance record for children shall be maintained that shall:

- 1. include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released;
- 2. accurately reflect children on the center premises at any given time; and
- 3. be used to sign in and out if a child leaves and returns to the center during the day.

1507.A. Based on record review at approximately 1:50pm, the center's daily attendance record for children did not include the departure times and first and last name of person or entity to whom the child is released for the following dates:

- -10/15/2020

Corrective Action Plan: Effective 10/19/2020, S1 stated all evening staff will check the clipboard prior to leaving the premises to ensure all children were signed out for the day.

1723.A.&B.: A. Infant and child CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR through training approved by the department.
