# Statement of Deficiencies

## 1723.A.&B.: CPR Certification

1723.A.&B.: A. Infant and child CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR through training approved by the department.

B. Adult CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in adult CPR through training approved by the department.

### Finding:

1723. Based on record review at 9:02 am, there failed to be fifty percent of staff members on the premises of the center and accessible to the children, or at least four staff on the premises and accessible to the children, whichever is less, that had current certification in infant and child CPR. This was not corrected prior to Specialist departure. S2 stated staff will be attending a class on 11/12/2019.

## 1723.C.: Pediatric First Aid

1723.C.: Pediatric First Aid. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in pediatric first aid through training approved by the department.

### Finding:

1723.C. Based on record review at 9:02 am, there failed to be fifty percent of staff members on the premises of the center and accessible to the children, or at least four staff on the premises and accessible to the children, whichever is less, that had current certification in pediatric first aid. This was not corrected prior to Specialist departure. S2 stated staff will be attending a class on 11/12/2019.

## 1725.A.-C.: Medication Management Training

1725.A.-C.: A. All staff members who administer medication shall have medication administration training.

B. Whether the center is administering medication or not, each early learning center shall have at least two staff members trained in medication administration and at least one on the premises. A staff member who is a licensed practical nurse (LPN) or registered nurse (RN) with a valid nursing license shall be considered to have medication administration training.

C. Such training shall be completed every two years with an approved child care health consultant.

#### Finding:

1725.A.-C. Based on record review at 9:15 am, there failed to be at least two staff members trained in medication administration. 1 of 3 staff present on the premises during this inspection had the medication management training.

## 1921.C.: Evacuation Pack

1921.C.: Evacuation Pack

- The center shall have an evacuation pack, the location of which is known to all staff, that at a minimum shall contain:
- 1. a list of area emergency phone numbers;
- 2. a list of emergency contact information and emergency medical authorization for all enrolled children;
- 3. an emergency pick up form;
- 4. first aid supplies, hand sanitizer, wet wipes, and tissue;
- 5. diapers for children who are not toilet trained and plastic bags for diapers;
- 6. a battery powered flashlight and radio and batteries or a crank flashlight and crank radio; and
- 7. disposable cups and bottled water.

### Finding:

1921.C. Based on record review at 1:55 pm, there center's evacuation pack failed to have a list of area emergency phone numbers, a list of emergency contact information and emergency medical authorization for all enrolled children, an emergency pick up form, a radio and batteries or a crank flashlight and crank radio, and disposable cups. This was not corrected prior to Specialist departure from the center.
