1723.A.&B.: CPR Certification

1723.A.&B.: A. Infant and child CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR through training approved by the department.

B. Adult CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in adult CPR through training approved by the department.

Finding:

NEW 1723. A.&B.:A. Based on record review/interview(s): At approximately 10:32am, S1 failed to have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in infant and child CPR through training approved by the department. One of three staff had documentation of this certification.

Corrective Action Plan: Effective 10/21/2020, S1 stated (via telephone) she will ensure there are always enough staff scheduled with CPR certification.

1723.C.: Pediatric First Aid

1723.C.: Pediatric First Aid. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in pediatric first aid through training approved by the department.

Finding:

NEW 1723.C. Based on record review:/interview(s): At approximately 10:32am, S1 failed to have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children or at least four staff on the premises and accessible to children, whichever is less, have current certification in Pediatric First Aid through training approved by the department. One of three staff had documentation of this certification.

Corrective Action Plan: Effective 10/21/2020, S1 stated (via telephone) she will ensure there are always enough staff scheduled with Pediatric First Aid certification.

1725.A.-C.: Medication Management Training

1725.A.-C.: A. All staff members who administer medication shall have medication administration training.

B. Whether the center is administering medication or not, each early learning center shall have at least two staff members trained in medication administration and at least one on the premises. A staff member who is a licensed practical nurse (LPN) or registered nurse (RN) with a valid nursing license shall be considered to have medication administration training.

C. Such training shall be completed every two years with an approved child care health consultant.

Finding:

1725A.-C. Based on record review/interview: At approximately 10:05am, S1 failed have at least two staff members trained in medication administration whether the early learning center administers medication or not. The last medication training was completed on 10/16/2017 and expired on 10/16/2019. Specialist spoke with S1 (via telephone), she stated she spoke with O2 from Agenda for Children on 10/20/2020 to schedule medication training; however, O2 stated she was not a certified trainer in medication administration and could not offer a class. S1 stated she is having problems finding a certified trainer in medication. Specialist provided S2 with a link of certified trainers in medication administration training. S1 and S2 stated a class would be scheduled as soon as a certified trainer can schedule one.

Corrective Action Plan: Effective 10/21/2020, S1 stated (via telephone) she will mark on a calendar when the renewal for medication training is needed before it expires.
