Statement of Deficiencies

1723.A.&B.: CPR Certification Not Met

1723.A.&B.: A. Infant and child CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR through training approved by the department.

B. Adult CPR. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in adult CPR through training approved by the department.

Finding:

1723.A.&B.: Based on Specialist's review of records at 11:00 a.m., S1 failed to have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children, or at least four staff on the premises and accessible to children, whichever is less, have current certification in adult, infant, and child CPR through training approved by the Department. 2 of 6 staff present had documentation of this certification.

Corrective Action Plan: Effective 10/27/2021, to ensure this deficiency is not recited, S1 stated she will schedule a Department-approved CPR training course to have all staff trained and certified by 11/27/2021.

1723.C.: Pediatric First Aid Not Met

1723.C.: Pediatric First Aid. Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in pediatric first aid through training approved by the department.

Finding:

1723.C. Based on Specialist's review of records at 11:00 a.m., S1 failed to have documentation that at least fifty percent (50%) of all staff on the premises and accessible to the children, or at least four staff on the premises and accessible to children, whichever is less, have current certification in pediatric first aid through training approved by the Department. 2 of 6 staff present had documentation of this certification.

Corrective Action Plan: Effective 10/27/2021, to ensure this deficiency is not recited, S1 stated she will schedule a Department-approved PFA training course to have all staff trained and certified by 11/27/2021.

1725.A.-C.: Medication Management Training

Not Met

1725.A.-C.: A. All staff members who administer medication shall have medication administration training.

- B. Whether the center is administering medication or not, each early learning center shall have at least two staff members trained in medication administration and at least one on the premises. A staff member who is a licensed practical nurse (LPN) or registered nurse (RN) with a valid nursing license shall be considered to have medication administration training.
- C. Such training shall be completed every two years with an approved child care health consultant.

Finding:

1725.A.-C. Based on Specialist's review of records at 11:00 a.m., S1 failed to have at least two staff members trained in medication administration, whether the early learning center administers medication or not. According to center records, 0 of 6 staff had a current certification in medication administration. S1 stated she and S5 have a current certification in medication administration, however, the certificates were not on site for Specialist to review.

Corrective Action Plan: Effective 10/27/2021, to ensure this deficiency is not recited, S1 stated she will obtain the medication administration certificates for herself and S5 to be maintained in staff files for review/verification at the next Licensing visit.
