1715-A.4 Based on record review documentation of a satisfactory fingerprint based criminal background check (CBC) was not available for 3 of 4 staff, prior to the individual(s) being present in the childcare facility (1703.A) S2, S3. and S4 date of hire is 11/14/16.

1723-A.&B.: CPR Certification

1723-A.&B.: Infant and child CPR

Fifty percent of staff members on the premises of a center and accessible to children, or at least four staff on the premises and accessible to children, whichever is less, shall have current certification in infant and child CPR.
