- 1721-A.-C.: A. Early learning centers shall provide opportunities for continuing education of staff members who are left alone with children, or who have supervisory or disciplinary authority over children.
- 1. Staff members of early learning centers, excluding foster grandparents, shall obtain a minimum of 12 clock hours of continuing education per center anniversary year.
- B. Staff members of type I, type II and type III centers who are neither left alone with children, nor have supervisory or disciplinary authority over children, shall obtain a minimum of three clock hours of continuing education in job related topics per center's anniversary year.
- C. Continuing education for all types of centers shall be conducted by trainers approved by the Licensing Division. The Licensing Division shall keep a registry of approved trainers.

## Finding:

1721-A.-C. Based on record review there failed to be evidence of required annual continuing education training for S1 for 2016-2017 licensing year and only CPR-First Aid for this year. Note: None of the other staff have had any training for this licensing year.

## 1725-A.-D.: Medication Management Training

1725-A.-D.:

- A. All staff members who administer medication shall have medication administration training.
- B. Whether administering medication or not, each early learning center shall have at least two staff members trained in medication administration.
- C. Such training shall be completed every two years with an approved Child Care Health Consultant.
- D. A licensed practical nurse (LPN) or registered nurse (RN) with a valid nursing license shall be considered to have medication administration training.

## Finding:

1725-A.-D. Based on record review there failed to be evidence of any staff having current medication administration training.

## 1901-J.-K.: Items That Can be Harmful to Children

**Not Met** 

1901-J.-K.: J. Items that can be harmful to children, such as medications, poisons, cleaning supplies and chemicals, and equipment, tools, knives and other potentially dangerous utensils, shall kept in a locked cabinet or other secure place that ensures they are inaccessible to children.

K. Plastic bags, when not in use, regardless of purpose or use, shall be made inaccessible to children.

## Finding:

1901-J.-K. Based on observations storage closet containing paint, insect spray, and ladder failed to be locked and inaccessible to the children in the school age building. Note: S1 locked closet during walk through.

## 1901-M: Strings and Cords
