Statement of Deficiencies

1103-A.-D.: Critical Incidents and Required Notification

1103-A.-D.: An early learning center shall make immediate notification to emergency personnel, law enforcement as applicable, and other appropriate agencies for the following types of critical incidents involving children in care:

- 1. death;
- 2. serious injury or illness that required medical attention;

3. reportable infectious diseases and conditions listed in LAC 51.II.105; and

4. any other significant event relating to the health, safety, or well-being of any child, including but not limited to a lost child, an emergency situation, fire or other structural damage, or cleaver of the center

- fire or other structural damage, or closure of the center.
- B. The parent shall be contacted immediately following any immediate notifications made under Subsection A.
- C. The Licensing Division and other appropriate agencies shall be notified via email within 24 hours of the incident.

D. The Licensing Division shall be notified by written report within 24 hours of the incident or the next business day. This written notification shall be made on the Licensing Division's Critical Incidents Report Form and shall contain all information requested on the form.

Finding:

1103-B. Based on record review/interview(s): S11 failed to immediately notify the Parent, O2, of the following critical incident: On 11/29/18, O1 contacted S11 by phone at 6:30pm to report an incident that was observed when O1 picked up her child at 4:55pm that day. S11 stated that O1 informed her that she had observed S8 hit C1 on the hand when she was picking up her child. An attempt to contact C1's parents was not made until 11/30/18 at 11:00am.

1501-A: Operations

1501-A: A center shall operate within the licensed capacity, age range, hours of operation and other specific services designated on its license.

Finding:

1501-A Based on observations: S11 did not notify the Licensing Division prior to making changes that had an effect on the license as the provider is using an indoor space as a classroom that was not previously approved by the Licensing Division. A room that was formerly being used for storage has now been turned into a classroom space and is currently being utilized.

1509-A.8. a-b: Behavior Management Policy

1509-A.8. a-b: Behavior Management Policy

Each center shall develop and implement a written behavior management policy describing the methods of behavior guidance and management that shall be used at the center.

The behavior management policy shall prohibit children from being subject to any of the following:

i. physical or corporal punishment which includes but is not limited to yelling, slapping, spanking, yanking, shaking, pinching, exposure to extreme temperatures or other measures producing physical pain, putting anything in the mouth of a child, requiring a child to exercise, or placing a child in an uncomfortable position.

ii. verbal abuse, which includes but is not limited to using offensive or profane language, telling a child to "shut up", or making derogatory remarks about children or family members of children in the presence of children;

iii. the threat of a prohibited action even if there is no intent to follow through with the threat;

- iv. being disciplined by another child;
- v. being bullied by another child;
- vi. being deprived of food or beverages;

vii. being restrained by devices such as high chairs or feeding tables for disciplinary purposes; and

viii. having active play time withheld for disciplinary purposes, except timeout may be used during active play time for an infraction incurred during the playtime.

Finding:

1509-A.8. a-b Based on interview(s)/observations: S8 used a prohibited method of discipline as a child, C1, was subject to corporal punishment. S11 informed Specialist that O1 reported witnessing S8 hit C1 on 11/29/18 when picking up her own child. Specialist review of video showed that at 4:56pm on 11/29/18, S8 popped C1 on the arm. S8 is still employed at the center.

1711-C: Posted Child to Staff Ratio in Classroom

1711-C: The Licensing Division form noting required child to staff ratios shall be posted in each room included in the center's licensed capacity.

Statement of Deficiencies

1711-C Based on observations: The Licensing Division form noting required child/staff ratios failed to be posted in each room included in the center's licensed capacity. The ratios were not posted in the new room that was formerly being utilized as storage.

1901-J.-K.: Items That Can be Harmful to Children

1901-J.-K.: J. Items that can be harmful to children, such as medications, poisons, cleaning supplies and chemicals, and equipment, tools, knives and other potentially dangerous utensils, shall kept in a locked cabinet or other secure place that ensures they are inaccessible to children. K. Plastic bags, when not in use, regardless of purpose or use, shall be made inaccessible to children.

Finding:

1901-J. Based on observations: Items that can be harmful to children, such as cleaning supplies and chemicals, were not kept in a locked cabinet or other secure place that ensures they are inaccessible to children. The cabinet in the 1 year old classroom was not locked and contained cleaning supplies and chemicals. The cleaning supplies were easily accessible to the children.

1903-C: Free of Hazards

1903-C: Indoor and outdoor areas shall be free of hazards.

Finding:

1903-C Based on observations: The indoor area was not free of hazards as 5 electrical outlets were uncovered in the new room. Outlets were covered during Licensing visit.
