## 1103-A-E: Critical Incidents and Required Notification

1103-A-E: An early learning center shall make immediate notification to emergency personnel, law enforcement as applicable, and other appropriate agencies for the following types of critical incidents involving children in care:

- 1. death:
- serious injury or illness that required medical attention; 2

reportable infectious diseases and conditions listed in LAC 51.II.105; and 3

4. any other significant event relating to the health, safety, or well-being of any child, including but not limited to a lost child, an emergency situation, fire or other structural damage, or closure of the center.

- B. The parent shall be contacted immediately following any immediate notifications made under Subsection A.

The Licensing Division and other appropriate agencies shall be notified via email within 24 hours of the incident. C.

- The Licensing Division shall be notified by written report within 24 hours of the incident or the next business day. This written notification shall be D.
- made on the Licensing Division?s Critical Incidents Report Form and shall contain all information requested on the form.
- Reporting deadlines may be adjusted in the event of a natural catastrophe and/or disaster, as determined by the Department. E.

#### Finding:

1103-A-E Based on observations: The Provider notified the Division of Licensing by written report within 24 hours of the incident or by the next business day. The written notification was made on the Licensing Division's Critical Incidents Report Form but failed to contain all information requested on the form as evident by there was no signature from C4's parent another person name unrecognized by director signed the form.

## 1711-A-B-D-G: Child to Staff Ratio

1711-A-B-D-G:

- Child to staff ratios are established to ensure the safety of all children.
- Minimum child to staff ratios shall be met at all times. Β.
- There shall be a minimum of two staff members present at an early learning center when more than one child is present. 1.
- Only those staff members directly providing care, supervision or guidance to children shall be counted in the child to staff ratios. 2
- D. Minimum Child to Staff Ratios for Type II and Type III centers:

G. Mixed Age Groups - Minimum Child to Staff Ratios

1. An average of the child to staff ratios may be applied to mixed age groups of children ages 2, 3, 4 and 5

- Child to staff ratios for children under age two are excluded from averaging. 2
- 3 When a mixed age group includes children younger than age two, the age of the youngest child determines the child to staff ratio for the group.
- An average may be applied to a mixed age group consisting only of children ages 5 and older. 4.

## Finding:

1711-A-B-D-G Based on interview(s): The Provider failed to meet the required child to staff ratio for children of the following ages: 3-4 year old children with 0 staff. The required ratio for children of this age is 13 children per 1 staff person.

## 1713-A&B&C: Supervision

1713-A&B&C:

A: Children shall be supervised at all times in the center, on the playground, on field trips, on non-vehicular excursions, and during all water activities and water play activities.

B: Children shall not be left alone in any room, (except the restroom as indicated in Subsection G), outdoors, or in vehicles, even momentarily, without staff present.

C: A staff person shall be assigned to supervise specific children whose names and whereabouts that staff person shall know and with whom the staff person shall be physically present. Staff shall be able to state how many children are in their care at all times.

## Finding:

1713-A&B&C Based on interviews: Children were not under supervision at all times as evident by on 12/02/2015 at approximately 8:25 AM two children were found in the breezeway with another child's parent with no staff.
