1103-A-E: Critical Incidents and Required Notification, based on record review, The provider failed to immediately notify the Parent of the following critical incident; C1 was left on the playground for 1-2 minutes before the S15 noticed and got her off of the playground. Incident occurred 12/1/16 @ 4:35PM and parent was not notified until 12/2/16 @ 8:17 AM the following day. Licensing was notified by fax and phoned on 12/2/16 @ 2:00 PM.

### 1507-A: Daily Attendance Records - Children

**Not Met** 

1507-A: A daily attendance record for children shall be maintained that shall:

- 1. include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released;
- 2. accurately reflect children on the center premises at any given time; and
- 3. be used to sign in and out if a child leaves and returns to the center during the day.

#### Finding:

1507-A: Based on record review, A daily attendance record for children shall be maintained that shall: include the child's first and last name, arrival and departure times, and first and last name of person or entity to whom the child is released. Specialist observed the attendance for the week of 11/28/16-12/2/16 and found several missing departure times and signatures of whom the child was released to.

1713-A&B&C: Supervision Not Met

1713-A&B&C:

- A: Children shall be supervised at all times in the center, on the playground, on field trips, on non-vehicular excursions, and during all water activities and water play activities.
- B: Children shall not be left alone in any room, (except the restroom as indicated in Subsection G), outdoors, or in vehicles, even momentarily, without staff present.
- C: A staff person shall be assigned to supervise specific children whose names and whereabouts that staff person shall know and with whom the staff person shall be physically present. Staff shall be able to state how many children are in their care at all times.

#### Finding

1713-A&B&C: Supervision. Based on record review, Children shall be supervised at all times in the center, on the playground, on field trips, on non-vehicular excursions, and during all water activities and water play activities. Based on this incident, C1 was left on the playground for 1-2 minutes until S15 realized and returned to get her.

#### 1901-Q: Staff Personal Belongings

Not Met

1901-Q: The personal belongings of center staff members shall be inaccessible to children.

#### Finding:

1901-Q: Staff Personal Belongings, based on observation, The personal belongings of center staff members shall be inaccessible to children. Specialist observed 3 purses out in the classrooms.
