Based on observations/interviews on 12/10/19, at 11:30am, although mandated reporters, S1 failed to report suspected abuse/neglect of a child to the Child Protection Statewide Hotline as on 12/5/19, S1 observed video of S8 forcefully laying C1,one-year-old on the cot causing him to bump his nose on the plastic outer part of the cot. S1 stated she did not know if she need to report the incident. S1 made report during specialist visit on 12/10/19.

1509.A.8.a.&b.: Behavior Management Policy

Each center shall develop and implement a written behavior management policy describing the methods of behavior guidance and management that shall be used at the center.

The behavior management policy shall prohibit children from being subject to any of the following:

- i. physical or corporal punishment which includes but is not limited to yelling, slapping, spanking, yanking, shaking, pinching, exposure to extreme temperatures or other measures producing physical pain, putting anything in the mouth of a child, requiring a child to exercise, or placing a child in an uncomfortable position.
- ii. verbal abuse, which includes but is not limited to using offensive or profane language, telling a child to "shut up", or making derogatory remarks about children or family members of children in the presence of children;
- iii. the threat of a prohibited action even if there is no intent to follow through with the threat;
- iv. being disciplined by another child;
- v. being bullied by another child;
- vi. being deprived of food or beverages;
- vii. being restrained by devices such as high chairs or feeding tables for disciplinary purposes; and
- viii. having active play time withheld for disciplinary purposes, except timeout may be used during active play time for an infraction incurred during the playtime.

1509.A.8.a.&b: Based on observation/record review on 12/10/19, at 11:30am, Although the center developed and implemented a written behavior management policy, S8 used a prohibited method of discipline as on 12/5/19, C1, age 1, was subject to physical punishment. Specialist observed the center's video recording from 12/5/19 at 11:59am show C1 was laying on cot for nap time, C1 sat up from cot facing S8. S8 forcefully repositioned C1 in the opposite direction causing him to bump his nose on the plastic bar area of the cot which caused a scrape on the bridge of the nose and mild bleeding.
