- 2. accurately reflect children on the center premises at any given time; and
- 3. be used to sign in and out if a child leaves and returns to the center during the day.

Finding:

1507-A Based on record review: The time of departure failed to always be documented for each child on each date.

1711-H: Rest Time - Minimum Child to Staff Ratio

1711-H: Rest Time - Minimum Child to Staff Ratios

- 1. Sufficient staffing needed to satisfy child to staff ratios shall be present on the premises during rest time and available to assist as needed.
- 2. Children ages one and older may be grouped together at rest time with one staff member in each room supervising the resting children. If two rooms share a common doorway, one staff member may supervise the resting children in both rooms.
- 3. If the view of the staff supervising the children is obstructed by an object such as a low shelving unit, children shall be checked by sight by staff circulating among the resting children.

Finding:

1711-H Based on observations: the required child to staff ratio failed to be met on this date during naptime at Specialist's arrival to the center. 15 two-four year olds were present with 1 staff; 5 infants with 1 staff and 7 toddlers-two year olds with 1 staff. One (1) additional staff was needed to meet child staff ratio for the 2-4 year old group.

1715-A.4: Criminal Background Check

1715-A.4: Staff Members. Personnel files for each staff member shall be maintained at the center and shall include the following: documentation of a fingerprint based satisfactory criminal background check

Finding:

1715-A.4 Based on record review: Satisfactory criminal background check failed to have been obtained for S3 who is a previous employed staff who returned to employment 7/18/17.

1723-C.-D. Based on record review fifty percent of staff members on the premises of a center and accessible to children failed to have current certification in Pediatric First Aid. 0 of the 4 staff present at the time of this visit had certification.

1725-A.-D.:

- A. All staff members who administer medication shall have medication administration training.
- B. Whether administering medication or not, each early learning center shall have at least two staff members trained in medication administration.
- C. Such training shall be completed every two years with an approved Child Care Health Consultant.
- D. A licensed practical nurse (LPN) or registered nurse (RN) with a valid nursing license shall be considered to have medication administration training.

Finding:

B.1725-A.-D. Based on record review: There failed to be at least 2 staff members trained in medication administration. Only one staff certified.

1901-M: Strings and Cords

Not Met

1901-M: Strings and cords, including but not limited to those found on equipment, window coverings, televisions and radios, shall be inaccessible to children under age 4.

Finding:

1901-M Based on observations: Cords hanging from wall air condition unit and a lamp in building #2.

1903-C: Free of Hazards Not Met

1903-C: Indoor and outdoor areas shall be free of hazards.

Finding:

1903-C Based on observations: Plastic Climbing Slide in outdoor play yard is cracked on one side which can cause a hazard to children.
